## BRIC PARKING

Parking at Boca Raton Innovation Campus is monitored and enforced by your vehicle's license plate. Please review the guidelines on the following pages to park safely and avoid ticketing. Any unregistered vehicle is subject to being towed without warning.

- Your vehicle must be registered to your current license plate. Please register or update your parking registration at <a href="mailto:truparkusa.com/">truparkusa.com/</a>
  <a href="mailto:BRIC-parking-request">BRIC-parking-request</a>
- Each employee should register their own vehicle. Please use your work email to register. If you use multiple vehicles on campus, register each vehicle and individual license plate.
- If your vehicle's license plate has changed, please update your parking registration by indicating the change at <a href="mailto:truparkusa.com/BRiC-parking-request">truparkusa.com/BRiC-parking-request</a> under "Type of Request."
- Please park with your license plate visible to the drive lane.

  License plates must be visible at all times, please do not cover your vehicles or back into a parking spot.
- You may park in any available, unreserved spaces near the fitness center outside of enforcement hours.



#### **VISITOR & CARPOOL PARKING**

All visitors parking on campus must park in parking spaces designated and marked for visitors. These spaces are marked with a white color block at the foot of the stall with visible signage at the front of each parking row.

Carpool/Vanpool users must register with FDOT Commuter Services at <a href="mailto:1800234ride.com/carpool/">1800234ride.com/carpool/</a> and send a copy of their FDOT registration to the Parking Director. Carpool parking spots are identified in majority of parking lots by designated signs.

#### **HANDICAP PARKING**

There are over 75 handicap spaces located throughout BRiC. These spaces are painted and posted with the appropriate signage. Please make sure your handicap parking sticker or hashtag is visible when parking in these spaces. Handicap spaces are available on a first come, first served basis.

#### **CONTRACTOR & VENDOR PARKING**

Contractors/Vendors may park in areas outlined in blue. Contractors/Vendors may use the loading dock areas to unload equipment and supplies, but vehicles must be moved to the designated areas for parking throughout their stay on campus. Contractors/Vendors that park elsewhere are subject to towing, at their own expense, without further warning. Contractors/Vendors are not permitted to park in front of a building.
